The Gazette Dissolution of a partnership refers to the change in the partnership relation between all the partners. In some cases, such as a partner leaving or a new partner joining, there may not be any change in the business of the partnership. In other cases, such as a court order or the death/bankruptcy of a partner, dissolution of a partnership may result in complete closure of the business of the partnership firm.

The dissolution of partnership among all the partners of a firm is called the Dissolution of the Firm (Sec. 39 of the Partnership Act, 1932).

Dissolution of Partnership involves a change in the relation of partnership business, if the

remaining partners resolve to continue the concern. In such cases there will be a new partnership but the firm will continue in a reconstituted form. Dissolution: Dissolution of firm means complete breakdown of the relation of partnership among all the partners.
